1. Personal data that we process

GiraSouls, LDA - Monte Naturista O Barão - processes your personal data because you use our services and/or because you provide this data to us yourself.

- Fiscal nr.
- ID number

Our website and/or services do not intend to collect data about visitors who are younger than 16 years of age. Unless they have permission from their parents or guardians.

2. For what purpose and on what basis do we process personal data?

GiraSouls, LDA - Monte Naturista O Barão - processes your personal data for the following purposes:

- Handling your payment
- To be able to call, app, text or email if this is necessary to provide our services
- Improving our services or business operations
- To inform you about changes to our services and products
- GiraSouls, LDA – Monte Naturista O Barão – also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.

Automated decision making

GiraSouls, LDA - Monte Naturista O Barão - accepts no responsibility for matters that may have consequences for people based on automated processing. This concerns decisions that are made by programs or computer systems, without a human being involved (for example an employee of GiraSouls, LDA – Monte Naturista O Barão). GiraSouls, LDA - Monte Naturista O Barão - uses the following programs or computer systems:

- WordPress
- Thelis Unix data
- Hi-Pay

3. How long do we store personal data

GiraSouls, LDA - Monte Naturista O Barão - does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected.

4. Sharing personal data with third parties

GiraSouls, LDA - Monte Naturista O Barão - does not sell your data to third parties and will only provide it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We enter into a processing agreement with companies that process your data on our behalf to guarantee the same level of security and confidentiality of your data.

However, GiraSouls, LDA - Monte Naturista O Barão - may share or transfer your personal information in connection with or during negotiations of any merger, sale of company assets, financing, or acquisition of all or part of the business to another company.

5. Cookies, or similar techniques, that we use

GiraSouls, LDA - Monte Naturista O Barão - only uses technical, functional and analytical cookies that do not violate your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical functioning of the website and its ease of use. They ensure that the website works properly and, for example, remember your preference settings. We can also optimize our website with this. You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via your browser settings.

6. View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by GiraSouls, LDA - Monte Naturista O Barão - and you have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organisation mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to montebarao@gmail.com.

To ensure that the request for access has been made by you, we ask you to enclose a copy of your proof of identity with the request. Leave your passport photo, MRZ (automatic reading zone, strip with numbers at the bottom of the passport), passport number and Citizen Service Number in black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks. GiraSouls, LDA - Monte Naturista O Barao would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

7. Protection of personal data
