EMERGENCY

The emergency number in Portugal is 112. In case of emergency you can contact the owners, Jeff and Laura, at any time in the canteen or by telephone (00351 936710623). Our information book, which you can find in the canteen, lists the addresses of the hospital (first aid), dentist and other services.

These rules and conditions are intended to maintain a safe, pleasant and sustainable environment at the park for everyone. We appreciate that you take note of these rules and conditions. We wish you a good stay.

1. Principle

Monte Naturista O Barão is a campsite where people are naked, weather permitting, and where people interact with each other and nature in a respectful manner.

2. Access

The campsite is open to anyone who puts into practice the principles set out in the previous point. Entry for children under the age of 16 is permitted as long as they are accompanied by their parent(s) or guardian(s). By entering the park you accept these rules and conditions. Management may at any time refuse guests access to the park or, if justified, exclude a guest.

3. Personal responsibility

Access to and stay in the park and participation in activities are at your own risk.

4. Arrival and departure

Upon arrival at the park, all guests are kindly requested to present proof of identity and/or membership card of the International Federation of Naturism. Upon arrival, guests should check prices, rules and conditions, etc. to avoid misunderstandings. Upon departure, we expect guests to leave their place clean and tidy, ready to receive the next guest.

5. Payment and settlement

We would appreciate it if you pay and check out before 12 noon on the day of departure.

6. Terrain

The gate must be closed by the guest entering or leaving the premises. The maximum permitted speed on site is 5 km/h (walking speed). There is an unfenced lake on the land. We ask that you supervise your children.

7. Quiet hours

After 11:30 PM there must be silence on the campsite and no cars are allowed to drive around.

8. Bar

It is not allowed to take drinks or food to the bar.

9. Swimming pool

For hygienic reasons it is mandatory to take a (cold) shower before using the swimming pool. Nudity is mandatory. Children up to 10 years old can only use the swimming pool if accompanied by responsible adults. The swimming pool is not supervised. Animals are not allowed around the pool and in the bathhouse. Drinks in bottles or glass cups are not allowed.

10. Waste and chemicals

Glass bottles and waste (in a closed bag) must be deposited in the waste bins to the right of the gate. You are not allowed to do this naked! Portable toilets, provided they are free of chemicals, can be emptied and washed at the designated location, to the right of the entrance, in our service area. It is not allowed to throw garbage, cigarettes or bottle caps on the ground.

11. Water

Water is a scarce resource. In more recent years, Alentejo has had its driest winters in the past 100 years. Therefore, we request that you do not use excessive amounts of water.

12. Environment and septic tank

We don't want toilet paper in the toilets. Dispose of your used paper in the appropriate container.

13. Fire or other hazard

It is not allowed to throw cigarettes on the ground.

In the period between April 1 and November 1, no form of fire is allowed, including barbecues. There are three barbecue areas on site, which can be used between November 1 and April 1.

14. Animals

Dogs must be on a leash and wearing a collar at all times. They have to relieve themselves outside the campsite. Owners must clean up their dog's feces in the park in case of "accidents." Stray dogs entering the park may not be fed and their presence must be reported to the campsite management.

15. Complaints

Report any complaints as soon as possible!
